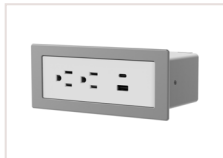

- ◇ Dealer’s account must be current with Dekko to qualify

NOTES:

- ◇ All payments will be made ACH
- ◇ After receipt of information the below, a link to a secured site (EGNYTE) will be sent for uploading completed W-9 and ACH information. (Documents must be received to process payment)
- ◇ Spiff can be split amongst 2 people (maximum) and must be shared 50/50
- ◇ Spiff is payable on all orders booked between August 1, 2023 - December 31, 2023
- ◇ Payments will be made once a month when the sales rep accrues \$100 or more in Spiff dollars
- ◇ All Spiff payments will be paid within 30 days of the paid customer invoice
- ◇ Spiffs must be claimed within 30 days of invoicing
- ◇ May not qualify on orders with negotiated pricing
- ◇ Taxes on spiff checks are the recipient’s responsibility. A 1099-Form will be issued at the end of the year
- ◇ The August 2023 Spiff program supersedes all previous Spiff programs released.
